Meeting was called to order at 7:30pm by youth Executive Director Camille Norczyk. Camille lead the American and 4-H pledges.

Roll Call and Quorum Check – An attendance sheet was passed around and the meeting quorum requirements were checked.

Meeting Ground Rules – The meeting ground rules were reviewed and discussed. It was decided to have the following continue as our fair board meeting Ground Rules

Treasurer's Report – Mary Lash reported the details of the 2016 fair income of \$5,994.21 and the expenses of \$5,994.21, which resulted in a loss of \$679.21. There is still some outstanding income to record for the 2016 SGV 4-H Fair from the pizza fundraisers. The fair account balance at the end of August, 2016 was \$14,606.08. Rick Herbert moved, Dee Keese seconded and it passed to accept the Treasurer's Report as presented.

Minutes Approval – It was moved by Dee Keese, second by Abigail Wright and passed to accept the minutes of the May 19, 2016 fair board meeting as posted on the fair website.

Old Business

Director election to be held at this meeting – It was moved by Dee Keese, seconded by Liliana Brown and passed to include the fair directors election in the agenda for this meeting. Although the election had not been included in the meeting agenda with the nominations of fair directors, the election had been announced in the prior fair board meeting minutes which were approved.

Order of Agenda – It was requested by Dee Keese to alter the order of the agenda items and approved to move the discussion of the fair theme to after the election of fair directors.

Election of Youth Fair Executive Director – Camille Norczyk and Wesley Rich were nominated. Wesley declined the nomination. It was moved by Rick Herbert, seconded by Mary Lash and passed to accept Camille Norczyk as the Youth Fair Executive Directory by acclamation.

Fundraising – To raise some money for the fair expenses, Camille suggested that we consider having some ads in our fair program for local restaurants. She will contact some restaurants in the Chino area about this. Peter Michel offered to set up a template for the ads. We might consider different sizes of ads with different costs.

Updates to the fair Handbook and procedures manual – Bring your comments and suggestions for updates to the SGV 4-H Fair Handbook and the SGV 4-H Fair Procedures and Policies Manual to the next fair board meeting for discussion.

One or two day fair – It was noted that at our September 18th, 2014 fair board meeting it was passed to have a one-day fair for the next three year so that there would be time to evaluate a one-day fair and determine if it can work successfully. In the approved minutes of that meeting it was further clarified that we had had a one-day fair for the last two years and after the next three years, we could re-evaluate the one or two day fair issue for the 2018 fair.

Fair Adult Finance Co-Director – It was moved by Dee Keese, seconded by Elizabeth Wright and passed to accept by acclamation Johanna Stewart as Finance Co-Director with Mary Lash.

Adjournment - The fair meeting was adjourned at 8:25pm.
