San Gabriel Valley 4-H Fair Board Meeting – September 24th, 2015

at Mary Lash's home (9497 E Foster Road, Downey, CA)

Meeting was called to order at 7:01pm by youth Executive Director Camille Norczyk. Camille lead the American and 4-H pledges.

Introductions – Rick Herbert moved, Wesley Rich seconded and it passed to postpone introductions at this time. Not many people had arrived for the meeting at this time.

Roll Call and Quorum Check – An attendance sheet was passed around and the meeting quorum requirements were checked. In a short time, enough people had arrived to satisfy the quorum requirements and the meeting was continued. Those participating in the meeting were reminded that only 2015 fair directors were allowed to vote at this meeting.

Treasurer's Report – Mary Lash reported the details of the 2015 fair income of \$5,212.36 and the expenses of \$5,934.36, which resulted in a loss of \$723.00. There is still some possible outstanding income to record for the 2015 SGV 4-H Fair. The fair account balance at the end of August, 2015 was \$15,174.91. Rick Herbert moved, Judylynn Pelling seconded and it passed to accept the Treasurer's Report as presented. Report is attached at end of these minutes.

It was moved by Victoria Rosenfield, seconded by Rick Herbert and passed to pay the invoice.

Minutes Approval – It was moved by Danielle Sevilla, second by Rick Herbert and passed to accept the minutes of the May 21st fair board meeting as posted on the fair website.

Old Business

Review of fair evaluations and suggestions from the prior fair – The committee decided that nothing further needed to be discussed from last year's evaluation of the fair. The new features of the Show Your Talent opportunity and the Create an Entry Reflecting the Fair Theme category went well so the committee agreed that they should be continued for this fair.

Missing 2015 club trophy – The Table Setting fair trophy was not located over the summer and a club did earn it for the 2015 fair. Victoria Rosenfield will look to see if she could possibly still have the trophy. Rick Herbert moved, Kathy Richards seconded and it passed that if the Table Setting fair trophy is not found by the October fair board meeting, the Table Setting trophy will be replaced.

New Business

Should Department Chairs be allowed to vote at fair board meetings? – The committee discussed the pros and cons of this topic. Chairs could provide good input. It might encourage chairs to attend the fair board meetings. Some issues directly affect the chair's department.

Chairs voting might increase the possibility of club vote loading. It was moved by Danielle Sevilla, seconded by Judylynn Pelling and passed to think about this topic further and vote on it at the October fair meeting.

Meeting Ground Rules – It was moved by Judylynn Pelling, seconded by Rick Herbert and passed to have the following as our fair board meeting Ground Rules

1. Respect other people's opinions

2. Be open-minded

7. No cross talk

3. No personal attacks

9. Welcome newcomers

5. Have one speaker at a time

10. Keep the goals of the 4-H program in mind.

One or two day fair – At our September 18th, 2014 fair board meeting it was passed to have a one-day fair for the next three year so that there would be time to evaluate a one-day fair and determine if it can work successfully. In the approved minutes of that meeting it was further clarified that we had had a one-day fair for the last two years and after the next three years, we could re-evaluate the one or two day fair issue for the 2018 fair. It was moved by Danielle Sevilla, second by Rick Herbert and then retracted that we reaffirm that one day fair decision and not vote this year on a one or two day fair. There was no motion to change to a two day fair for this year.

Fundraising – We lost money running the fair last year. Perhaps we should consider doing some fundraising this year to help cover the expenses of the fair. It was suggested that we ask each club in the NSG and SSG districts to do some special fundraising for the SGV fair. Each club could decide how they would do the fundraising. It was suggested that there should be a goal amount set for the clubs. Some concern was mentioned that small clubs barely can raise money enough for their own club expenses and having to raise additional money for the fair would be difficult. It was suggested that another option would be to ask for donations from businesses and other contacts. It was decided that we needed a clarification from the county 4-H office about the procedures for seeking donations and doing fundraising for the fair. Marjorie Rodriguez said she would contact Keith Nathaniel in the county 4-H office about this. It was decided to discuss this further at the next fair board meeting.

Adjournment - The fair meeting was adjourned at 9:01pm.
